### **BUDGET 2024/25 AND CIL REPORT**

- 1. Preliminary consideration of the budget for 2024/25 was undertaken at the meeting on 9<sup>th</sup> November 2023. The draft revenue budget, approved at that meeting, is included in Table 1 below. Actual outturn expenditure continues to be less than the budget. The particular budget lines that usually underspend are Donations (500/0 in 2023/24), Minor Works Programme (1000/0) and Repairs and Maintenance (1000/310). We could reduce all of these budget lines to make the budget more closely aligned with the reality of what we normally spend.
- 2. Subject to consideration of the point made in para 1, budgeted expenditure for 2023/24 is approximately £5,600. The balance of the accounts at 31<sup>st</sup> March 2024 was just under £20,000. To that must be added the Precept for 2024/25 of £7,500. There is therefore, once again, a danger that the Parish Council will be building up its reserves. This cannot be justified if there are no plans for major expenditure.
- 3. There is, however, the uncertainty regarding possible expenditure on the speed limit assessment and the legal and signage costs associated with any reduction in speed limits on the C12. We were told that Bishopstone's share of the consultants costs of the assessment would be £362.50. However, Wiltshire subsequently extended the assessment to cover the length of the C12. It is not yet known whether the parish's contribution to the cost of the assessment is still required. If the bid for a reduced speed limit is successful the contribution to legal and signage costs could be in the range £3,000-£4,000. At this stage there is no alternative but to assume that these costs could be incurred. However, if they are not there will be a need either to find another major project to undertake this year (tree planting?) or to severely reduce the precept for next year, possibly to zero.

## **CIL Expenditure Return**

- 4. During 2023/24 the Council received a Community Infrastructure Levy (CIL) payment in respect of the re-development of Sanclive in Chapel Lane. This amounted to £2,741.68. The CIL regulations state that the funds must be used: "to support the development of the local area by funding:
  - (a) The provision, improvement, replacement, operation or maintenance of infrastructure; or
  - (b) Anything else that is concerned with addressing the demands that development places on an area."

The Parish Council is required to prepare and publish an annual report detailing CIL funds received and spent. These funds have to be spent within five years or returned to Wiltshire Council. The funds don't all have to be spent in any one year and can be carried over within the five year period. A table setting out a proposed CIL Report for 2023/24 is attached at Annex B. I consider that the expenditure items included (the bench and the defibrillator) meet the criteria set out above. A small amount (£92.00) will be carried over for spending in the current year.

## Recommendations

# 5. Councillors are invited to:

- (i) Consider whether any adjustments need to be made to the budget for 2024/25 and then formally approve the budget.
- (ii) Suggest any additional projects that might be brought forward for this coming year.
- (iii) Approve the proposed CIL Report for 2023/24.
