1. Apologies for Absence

There were none.

2. Declarations of interest

There were none.

3. Approval of Minutes of the meetings on 9th January 2020.

NTB proposed that the minutes of the meeting on 9^{th} January 2020 be approved as a correct record, this was seconded by PE and agreed.

4. Matters Arising from the Minutes, including Action Plan.

Matters Arising, not otherwise included on the agenda, were as follows:

- (i) MRA reported that the new snow and ice grit bin was now in place at the entrance to the resident's car park in Whitlock Rise. He was very grateful to Jerry Steedman for providing an initial supply of grit.
- (ii) Wessex Contract Supplies had submitted quotations for boarding up and securing the toilet building on the Recreation Field. Using marine ply would cost £460.50 and sheet steel, primed and painted, would cost £438.50. AJT proposed that the quotation to use sheet steel be accepted, this was seconded by PE and agreed.

5. Report from Wiltshire Councillor Jose Green

Cllr Green gave a short report. In this she referred to Wiltshire Council's commitment to become carbon neutral by 2030. In connection with this, scrutiny panels were looking at the scope for amending planning and building control regulations, the use of electric buses, sustainable energy provision to council owned buildings, street lighting and the use of more efficient vehicles for rubbish and re-cycling collections. A Salisbury Transformation Programme is being prepared. A total of 11,000 potholes had been filled in the last year and the number of claims for damage to cars had reduced.

6. Public Forum.

Concerns were raised about Government infrastructure planning and the pot holes at the bottom of Flamstone Street. MRA said that the latter had been reported to Wilsthire Council.

7. Chairman's Items

No matters were raised.

8. Emergency Planning Update

Roger Stockton reported on flooding in the village. The Environment Agency had issued an "Alert" in relation to flooding from groundwater. However, thankfully, there were few signs of springs emerging this year. Meetings were being held with the Environment Agency and the Cranborne Chase AONB to discuss use of the Lottery Grant received by the AONB and possible projects related to flooding and the River Ebble.

In relation to the Coronavirus pandemic, it was pointed out that the Bishopstone Emergency Plan has a section on dealing with pandemics, the first action being the establishment of an Emergency Committee to draw up arrangements for local action. It was agreed to begin this process.

9. Parish Clerk's Report

(i) Expenditure Items

MRA reported that a sum of £1310.26 had been successfully reclaimed from HMRC in respect of VAT paid in 2017/18, though some of this would need to be shared with Broad Chalke and

Bowerchalke Parish Councils as it related to the joint purchase of the Speed Indicator Device. He also presented two items of expenditure for approval: £189.06 for the new grit bin in Whitlock Rise and £120.00 as the annual hire costs for the Village Hall. AJT proposed that these items of expenditure be approved, this was seconded by NTB and agreed.

(ii) Green Spaces Survey

MRA said that Wiltshire Council were conducting a survey of green spaces in each parish area, how they were used and on the demand for more such facilities. He said he would prepare a draft response and circulate it to Councillors for approval.

(iii) Litter Pick

Proposals for a litter pick as part of the Great British Spring Clean had been proposed in the latest edition of STaB. Only three volunteers had come forward. Without further interest this would not take place.

10. Planning Matters

Consideration was given to proposals for the extension of Oak House in Harvest Lane. It was agreed to send a "no comments" return to Wiltshire Council.

11. Questions or statements from Councillors.

There were none.
